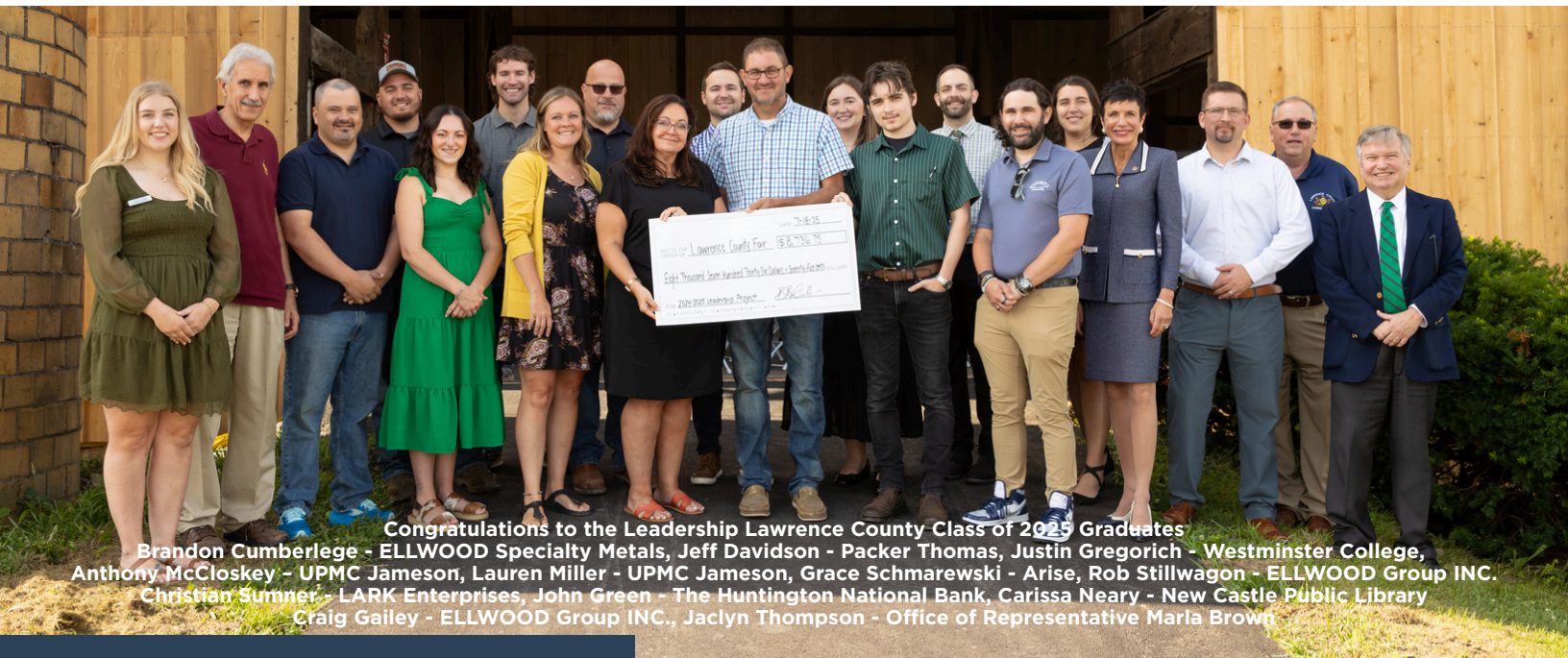

SMOKIN' STEER EXPANDS WITH LAWRENCE COUNTY'S SSBCI LOAN PROGRAM

There's a new chapter unfolding for one of Ellwood City's most delicious local businesses. Thanks to a combination of hard work, community banking support, and Lawrence County's State Small Business Credit Initiative (SSBCI) Revolving Loan Fund, Dave and Ann Hunter, owners of Smokin' Steer BBQ, have purchased the building they once rented at Creekside Commons, cementing their roots and opening the door to even bigger plans.



"This is exactly the type of success story the SSBCI program was designed to support," said Art Clinger of FNB, who worked closely with the Hunters to secure financing. "We're eager to work with local entrepreneurs on expansion projects like this, whether they involve property purchases, equipment upgrades, or renovations. Together, we can finance projects up to \$1.5 million." Through SSBCI, businesses can apply for loans ranging from \$10,000 to \$500,000, typically structured as a 1:1 match with a partnering bank. A third round of funding from the SSBCI program is expected in 2026. Loans are offered at a fixed rate, generally Prime minus 2%, making this a flexible and affordable option for small businesses looking to grow.

Creekside Commons, located in Ellwood City, is home to Lori L's Salon, NovaCare Rehabilitation, Soother Tanning, and now the expanding Smokin' Steer BBQ. By purchasing the property, the Hunters gain long-term stability and the ability to grow their operations while keeping space available for these other valued tenants. Smokin' Steer will now occupy more than half of the building, while continuing to serve as a cornerstone destination for local barbecue fans. The purchase was made possible through a financing partnership between First National Bank (FNB) and the Lawrence County Economic Development Corporation (LCEDC). LCEDC's SSBCI loan program provides fixed, low-interest loans for building acquisition, renovations, equipment purchases, and expansion projects. These loans are designed to assist rurally disadvantaged businesses, a category that includes all of Lawrence County.

ROOTED IN COMMUNITY: BUILT FOR GROWTH



For Dave and Ann Hunter, this marks another milestone in a journey that started with Smokin' Daves BBQ, a dream of bringing flavorful, slow-cooked barbecue to the community. In addition to their restaurant, the Hunters also operate two semi-trailers, which allow them to bring Smokin' Steer to local events, cater special occasions, and even make regular appearances at places like the Pitt Raceway. Purchasing their building gives Smokin' Steer BBQ a solid foundation for future growth. It also helps ensure that Creekside Commons remains a vibrant hub of local services and businesses for years to come. If you're a small business owner in Lawrence County with plans to expand, renovate, or invest in equipment, the SSBCI Revolving Loan Fund might be the tool you need. US DOJ OFFICE FOR SERVICES FOR VICTIMS OF CRIME – FUNDING OPPORTUNITY

Grants.gov applications due August 15, 2025

JustGrants applications due August 20, 2025

This NOFO supports the development, expansion and strengthening of victim service programs for all victims of crime throughout the United States and its territories. Award recipients will increase the quality and quantity of victim services in the following categories:

Victim services may include, but are not limited to, emergency assistance, case management, shelter and housing, medical and dental care, victim advocacy, transportation, childcare, legal services, and employment assistance. Entities may only submit one application. Entities may only apply to one category in their application.

Category 1

Services to Child and Youth Victims (Anticipated Award Ceiling: \$500,000) Awards under this category will be made to entities to serve child and youth victims of crime. Child and youth victims are persons who were age 17 or younger when the victimization took place.

Category 2

Services to Victims of Elder Abuse, Fraud, and Exploitation (Anticipated Award Ceiling: \$500,000) Awards under this category will be made to entities to serve victims of elder fraud, abuse, and exploitation. For purposes of this NOFO, victims of elder fraud, abuse, and exploitation are persons who were age 55 or older when the victimization took place.

Category 3

Services to Other Crime Victims (Anticipated Award Ceiling: \$500,000) Awards under this category will be made to entities to serve other victims of crimes (not child or elder victimization), excluding human trafficking.

✿✿ DAIRY PROCESSOR ✿✿ Modernization Grant Program

Grant Overview

The Northeast Dairy Business Innovation Center (NE-DBIC) announces the availability of funds through the Dairy Processor Modernization Grant program to address the significant need for investment in processing infrastructure in the Northeast. Funds will support dairy processors and dairy brands in modernizing their production to allow for increased processing of regional dairy, long-term business viability, and ability to meet consumer demands. Projects funded through this grant will focus primarily on acquiring specialized equipment for dairy processing that offers benefits such as increased capacity, higher efficiency, reduced energy usage, increased quality, or ability to produce new or higher-value products. Projects that benefit more than one dairy business and those that incorporate technical assistance may be more competitive. Grants are available to dairy processors and dairy brands working with co-packing processors in all Northeast states: Connecticut, Delaware, Maine, Maryland, Massachusetts, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, and Vermont. Applicants will qualify into one of two award tiers based on their processing volume.

Grants will range from \$15,000 to \$250,000 with a 25% (cash or in-kind) match commitment required. At least 75% of grant funds must be used for eligible specialized equipment purchases.

Total funds available: \$1,000,000.

Eligibility

These grants are for projects that will directly benefit dairy processing in the Northeast region (Connecticut, Delaware, Maine, Maryland, Massachusetts, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, and Vermont).

To be eligible for this grant, you must fall into at least one of the following groups:

1. Dairy Processors that
 - Transform raw fluid milk, dairy components, or dairy mix into an edible product meant for human consumption; and
 - Are headquartered or based in the Northeast; and source or produce milk or dairy components from within the Northeast; and
 - Manufacture products within the Northeast; and
 - Hold a license as a dairy processor that permits the sale of their dairy products across state lines, even if they are not currently selling interstate.

2. Dairy brands that market Northeast dairy products produced by a licensed dairy processor under a co-packing or other arrangement. For the purposes of this grant, a dairy brand is a business that develops and markets dairy products but may not operate its own processing facilities. Dairy brands own the rights to their products' recipes, branding, and distribution, but work with licensed dairy processors, such as co-packers, to produce their products. White-label retailers, who rebrand products developed and produced by another company but do not own exclusive rights to the product, are not eligible. Dairy brands are eligible if:

- The project primarily benefits at least one dairy product meant for human consumption that is produced by a Northeast processor that meets all eligibility requirements as defined above; and
- A Letter of Commitment from the partner processor is included in the application.



Special note for co-packing, processing partnerships, and dairy brands: If a grant project involves both a dairy brand and a processing partner, the primary applicant should be whichever entity will own the equipment or supplies purchased under the grant. For instance, if a dairy brand needs a specialized filler but their processing partner will own the equipment, the processing partner should be the grant applicant and the dairy brand would be listed as a project partner. Please contact the Grant Program Manager if you have questions about who the applicant should be.

Prior to award, we may confirm your compliance (or that of your processing partner, in the case of dairy brands) with applicable licensing standards.

Applicants will qualify in tiers outlined below based on how much milk or dairy mix they use on an average production day, regardless of the number of days per week they process. Volume may differ based on the product made and you should refer to the volume measurement for your specific product. For example, cheese producers measure pounds of milk while an ice cream manufacturer would likely purchase gallons of mix. Volume is a measurement of inputs, not finished products.

1. Review the full **2025 Dairy Processor Modernization Request for Applications (RFA)** for the complete details on eligible projects/applicants and the full application process.
2. Register in **WebGrants** (may take up to two business days).
3. Complete your application in WebGrants using our **Application Guide**. **The application will be open until August 14, 2025 at 2:00 PM ET.**
4. Applicants who do not already have a Unique Entity Identifier (UEI) through SAM.gov are strongly encouraged to start this process during the application period to ensure a timely start to their grant, if awarded.

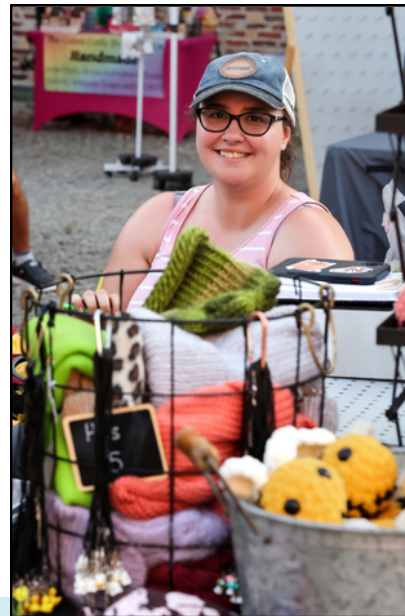

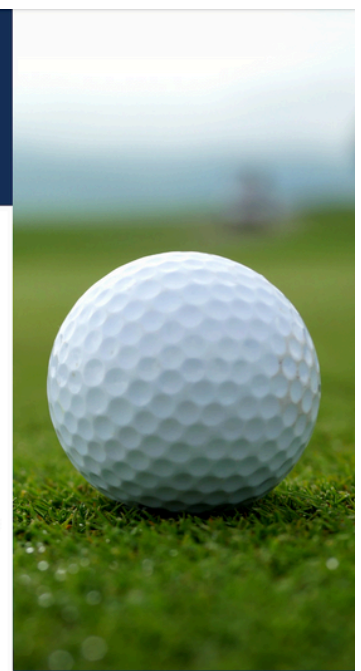
